

COVID CONFUSION

Hanna calls for 'clarity' on the new restrictions SOUTH Belfast MP Claire Hanna (right) has called for more clarity over the recentlyintroduced batch of new Covid restrictions.

In their first joint press conference since the bitter fallout over the Bobby Storey funeral, First Minister Arlene Foster and deputy First Minister Michelle O'Neill revealed a raft of new postcode restrictions that take in the whole of the greater Belfast area as well as other identified districts across the north.

But Ms Hanna said she

believes the message that's been put out is "a little confused" and has asked for the detail to be refined so that people are clear about what they can and can't do.

Among the restrictions now in operation is a ban on groups of more than six gathering in private gardens; no unnecessary travel outside the listed areas; the curtailing of visits to care homes and hospitals.

Mrs Foster said she realised the new rules would cause "anxiety" in affected areas. Full story, page 8
