ANOTHER COVID RISE

Finaghy tops list as all South Belfast postcodes see jump in cases

THE number of Covid cases has again surged in all postcodes across South Belfast – with Finaghy again the worst-hit local district.

BT10 has the highest rate in South Belfast with 741.3 cases per 100,000 people.

The Saintfield/Carryduff BT8 district is next on the

table, followed by BT9 (Malone, Lisburn Road) and then BT7 (Ormeau, Botanic).

South Belfast Alliance MLA Paula Bradshaw has urged

people to abide by the Covid regulations as we move into a new and comprehensive lockdown.

“The increasing evidence

the virus spreads through aerosol transmission means it is not sufficient merely to maintain bubbles and two-metre distancing,” she said.

“Anyone sharing an indoor location with an infected person for any length of time is at risk of getting and thus spreading the virus.” P4.
