BOYNE BRIDGE PROTEST

Sandy Row residents step up their campaign to save crossing with historic links to 1690

THE campaign to save the Boyne Bridge at Sandy Row is

to be stepped up with a protest march from the local Orange Hall to City Hall. The Boyne Bridge

Defenders Historical Group aims to stop the demolition of the current bridge, which is to go to make way for a multi-

million pound new transport hub in the Grosvenor Road/Sandy Row area. It's thought that Prince

William of Orange may have crossed the bridge in June 1690 on his way to the Battle of the Boyne.

Archaeological remains are situated under the bridge that's set to be removed. See story, page 4
