VACCINE DEMAND UP

RVH opens daily for walk-in jabs to meet rising demand across the age groups

A SOUTH Belfast fire station is one of a number of facilities to open for walk-in Covid

vaccinations as demand for jabs across age groups continues to rise.

The Joint Committee on Vaccination and Immunisation

this week recommended the phased extension of the Covid-19 booster jab to a wider age profile.

Belfast Central Fire Station

in Ormeau Avenue is to open at weekends for all vaccinations as appropriate while the RVH will open daily.

Health Minister Robin

Swann welcomed the further roll-out of the vaccination programme as the Omicron variant spreads.

He said: “Our vaccination

programme will continue to pull out all the stops to bring booster doses to all eligible age groups as quickly as possible.”
