DÁITHÍ'S LAW KICKS IN

Now people will be placed on organ donation register unless they choose to opt out

A FIVE-YEAR battle by a Belfast family for an improved

organ donation system finally paid off this week with the enactment of 'Dáithí's Law'.

Dáithí Mac Gabhann has

been on the waiting list for a heart transplant since 2018. During this time his family have worked tirelessly to

campaign for a move towards soft opt-out law and to promote organ donation. It was June 1 five years ago

when Dáithí was placed on the waiting list for a new heart.

This week the new law kicked in, meaning that people

living here will be placed on the organ donation register unless they choose to opt out.
