PLANNING permission has been given for a £50m housing

development in the Four Winds area of South Belfast.

Work is expected to begin later this year, creating, 60

construction jobs during the process of bringing much-needed family homes to the popular area of South Belfast.

A spokesperson for the developer said: "We're pleased to now be able to bring new homes, including 29 affordable

homes, to an area that in recent years has seen increasing demand for housing.

"We hope to start construction work as soon as possible."
