of an announcement of over £2 million of grants from The National Lottery Community Fund to provide support and

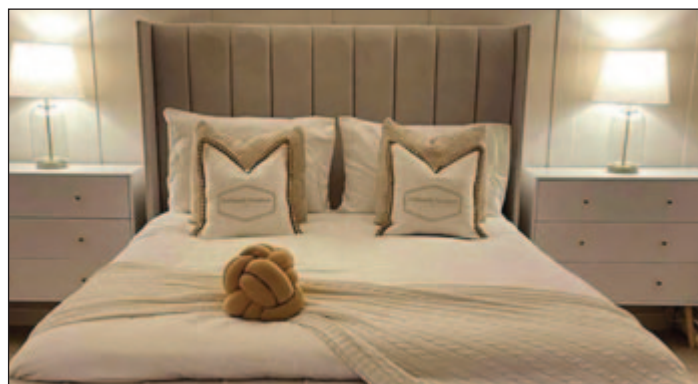
services to local people across the North.
