SUICIDE CRISIS DEEPENS

Worrying new statistics should set alarm bells ringing says mental health expert

BY CONOR MCPARLAND

A SHARP rise in the number of people taking their own

lives should set alarm bells ringing in the Stormont Executive, a mental health campaigner says.

The latest Registrar General's report shows that the number of suicides in the year 2023 was up 8.87% on 2022.

Males from poorer areas continue to form the vast majority of the dead.

"This is a very worrying

rise from the previous year and going in the wrong direction, especially given that we have a suicide prevention

strategy in place for the past five years," an expert in the field tells us today.
