Bookies cop to be charged

Allegation of false threat report in wake of Ormeau Road commemoration clash

A POLICE officer who allegedly filed a false threat

report in the wake of a confrontation at a Sean Graham bookies commemoration clash is to be charged

with conspiring to pervert the course of justice.

Emotional relatives of the 1992 bookies massacre reacted

furiously when police intervened to break up an anniversary commemoration at the site in February 2021.

A surviving victim of the UDA atrocity was arrested and a massive political row erupted over the decision by

police to take action against the event citing the then current Covid restrictions.
