resident whose body has been found in Spain, says he just wants to bring his son home. Billy George says his family

cannot thank the people of Belfast enough for the support they have shown over the last few weeks as the search for

the missing 37-year-old continued.

"I came out here to get my son and said I was not leaving

until I got him back home," he said.

Lawyers acting for the family have appealed for them

to be given privacy at this difficult time to allow them to consider their next move.

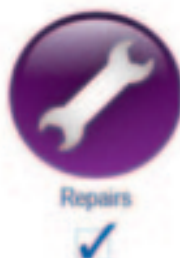
