# KIDS' HOSPITAL GOOD TO GO

First sod to be turned within days on new £671 million development at the RVH

WORK is about to begin on the new £671 million Children's

Hospital at the Royal Victoria Hospital.

Construction is expected to last for five years. On

completion the hospital will have 155 beds, 10 theatres and an emergency department capable of dealing with 45,000

children a year. The works costs will be spread over the five-year construction period and will be funded from the

Department of Health capital budget, rather than taking a huge chunk out of the separate budget for day-to-day
