# Sandy Row hire company targeted in nighttime attack on Dunmurry yard

A SANDY Row bus hire company has been left

devastated after three of its coaches were completely destroyed in an arson attack. The vehicles were parked in the Seymour Hill Industrial Estate when they were set alight around 9.40 on Wednesday evening. Police are treating the incident as a deliberate arson atttack and have appealed to the public for information.

"We would be particularly interested in hearing from anyone who may have been in the vicinity of the lower end of Seymour Hill housing estate, or Seymour Hill Industrial Estate," the PSNI said.




