

work on new Irish school gets under way

fit-for-purpose new building

A NEW era has dawned for the Irish language in South Belfast after the first sod was cut this week on a new Ormeau Road Gaelscoil.

Almost 30 years after Scoil an Droichid welcomed its first pupils and parents to a Portakabin in Cooke Street, work is under way on an all-new school and nursery

Scoil an Droichid has been operating out of temporary buildings for the entirety of its existence and today principal Claire Donnelly tells us of her delight that the school is finally to get the home it deserves.

She said: "We are delighted to reach this stage now that work has started. It has been a very long planning process. I think it has been 11 years since Minister O'Dowd announced we were on the list for school capital funds.

"A new school is badly needed. We are currently operating in second and third hand mobile-type units and they are just not fit for purpose.'
