DRUGS FIND AFTER FOUR FALL ILL

POLICE have found a quantity of drugs after four people were

removed from a property in the Holyland and taken to hospital after falling ill. Police, the Fire Service and the Ambulance Service were called to the house in Damascus Street on Tuesday evening. Four people inside the property were taken to hospital and have since been released. In a statement on Wednesday morning, police said they were investigating “potential contact with a possibly noxious substance”.
